

### **Account Aggregation Request Form**

\_\_\_\_\_ (hereinafter “Building Owner”) has made a determination that it is subject to the Energy Empowerment Ordinance (Sections 18-500 through 18-508) that has been enacted by the City of Kansas City, Missouri (hereinafter “KCMO”). Under the ordinance, KCMO requires owners of certain building sizes to benchmark and report annual energy use. Building Owner has requested assistance from Evergy in gathering aggregated data for building(s) subject to the ordinance. Evergy is willing to provide such assistance, subject to the following conditions:

- 1) Evergy will not provide data that is identifiable to any specific Evergy customer in the building other than the Building Owner. If a multi-tenant building has fewer than five (5) Evergy metered account holders that are different than the Building Owner, then Building Owner is required to obtain an executed release from each account holder in the form attached hereto as Attachment A and provide the releases to Evergy before this request form will be deemed to be complete.
- 2) The information is provided “As Is”. While Evergy will endeavor to provide accurate data based on the information provided, it makes no representations or warranties that the data will error-free or complete.
- 3) If an Agent Company is identified below, Building Owner hereby authorizes Evergy to provide the necessary information for all Building Owner accounts to the Agent Company.
- 4) Building Owner shall indemnify, defend and hold harmless Evergy and its officers, employees and agents from all claims, liabilities and damages incurred by Evergy as a result of the assistance it provides under this agreement, except to the extent caused by the gross negligence or willful misconduct of Evergy.
- 5) Incomplete or inaccurate request forms cannot be processed. Evergy requires 30 days to process a complete request form before aggregation data can be provided.
